# 1. Introduction

# a) Purpose of this Certification

This exam aims to demonstrate the professional's knowledge of the fundamentals of digital governance.

### **Digital Governance Concepts**

The purpose of this unit is to help the candidate to define the concept of Digital Governance, and to comprehend and explain it as a practice.

Describe the concept of digital governance and the main areas that supports it.

Understand the importance of adopting a digital governance framework.

### Roles & Responsibilities

The purpose of this unit is to help the candidate to understand the roles and responsibilities within a digital team and what is its contribution to the Digital Governance.

The recommended study period for this unit is 2 hours

Identify and define the components of a digital team.

Understand and define the roles and responsibilities of the core digital team in the implementation and maintenance of a digital governance framework.

Understand and define the roles and responsibilities of the other components of the digital team (besides the core team) that collaborate in the implementation and maintenance of a digital governance framework.

### Digital Strategy

The purpose of this unit is to help the candidate to comprehend the importance of a digital strategy and its relation to the context of Digital Governance

The recommended study period for this unit is 2 hours.

Understand the main concepts and inputs related to the digital strategy.

Define the roles and responsibilities involved with digital strategy definition.

# Digital Policy Understand the main concepts and inputs related to the digital strategy.

The purpose of this unit is to help the candidate to explain the main attributes of a digital policy adequate for the purposes of Digital Governance.

The recommended study period for this unit is 2 hours.

Understand the reasons to adopt a digital policy and explain the main attibutes of a digital policy.

Define the responsibilities for stewardship and authoring related to a digital policy.

Describe the good practices that must be used to write digital policies.

### **Digital Standards**

The purpose of this unit is to help the candidate to understand how a proper approach of digital standards is a fundamental pillar for the success of a Digital Governance program.

The recommended study period for this unit is 4 hours.

Define digital standards and understand the reasons to adopt them in a digital governance context.

Define the responsibilities for stewardship and authoring related to digital standards.

Describe the practices that must be used to define, document and disseminate digital standards.

### **Design Factors for Digital Governance**

The purpose of this unit is to help the candidate to comprehend the main design factors that infuence or are influenced by the Digital Governance framework design process in an organization.

The recommended study period for this unit is 4 hours

Identify the design factors that influence or are influenced by digital governance.

Explain how the corporate governance dynamics affects the digital governance framework.

Understand the influence of the external demands over the digital governance framework.

Describe which are the impacts of the Internet ecosystem for the digital governance.

Explain how the digital governance is influenced by the organizational culture.
